### Foreword

e are very pleased to present this first edition of *Atlantic Currents*, a new annual report charting Wider Atlantic perspectives and patterns. The report is the result of a close collaboration between the German Marshall Fund of the United States and the OCP Policy Center, and is a companion to the *Atlantic Dialogues* initiative, our annual forum in Morocco. Both activities are part of a multi-year partnership to promote dialogue and analysis on issues affecting the Wider Atlantic — the United States, Europe, Africa, Latin America, and the Caribbean — as well as global stakeholders in Atlantic affairs.

GMF and the OCP Policy Center are proud of the role we have played in extending the transatlantic debate to embrace the Atlantic Basin, north and south, and in stimulating new thinking about "Atlanticism" for the 21<sup>st</sup> century — rethinking mental maps of the Atlantic in economic, political, and security terms. The United States and Europe have a strong stake in this exercise, alongside Morocco, as do societies across the southern Atlantic. The essays and data presented here illustrate disparities, but also point to striking elements of convergence between the North and South Atlantic, with important implications for prosperity and security. Above all, these analyses illustrate the continued vitality of Atlantic societies, and the centrality of transatlantic relations in international affairs.

We wish to thank all the authors who have contributed to this first edition of *Atlantic Currents*. We are especially grateful to the project leader, Timothy Ridout, Wider Atlantic fellow at GMF; to the OCP Policy Center team; and to Christine Chumbler, publications manager at GMF.
